Applications in prescribed form are invited from the deserving candidates of Cuttack District for engagement in the following categories of posts in ST & SC Development Department Educational Institutions in Cuttack District purely on contractual basis.

(1) ELIGIBILITY CRITERIA :

(i) He/She must be a citizen of India. (ii) He/She must be a B.Sc, B.Ed. (iii) He/She must be a permanent resident of Cuttack district. (iv) He/She must be under 32 years and over 21 years of age on the 1st day of January, 2007 (Relaxation of upper age limit in case of Women & ST candidates by 5 years will be allowed). (v) He/She must have registered his/her name in any Employment Exchange. (vi) He/She must have passed H.S.C. Examination with Oriya as a subject.

2. ENGAGEMENT CONDITION :

(i) The engagement on contract will be valid up to the end of February of the current financial year from the date of engagement and can be terminated earlier if he/she violates the conditions of contract or is found unsuitable by the authority without assigning any reasons. (ii) The renewal of contract engagement can be considered only if continuance of the post is extended with concurrence of Finance Department and subject to satisfactory performance by the candidate to be evaluated by the competent authority. (iii) A contract engagement shall be executed between the Collector on behalf of the State Government and by the contract person to be signed on Stamp Paper. (iv) A written undertaking shall be submitted by the contractual appointee in the model form prescribed for the purpose.

3. ENCLOSURES TO BE ATTACHED WITH THE APPLICATION FORM :

(i) Attested Xerox copy of certificate showing academic qualification with mark sheet (from HSC to minimum qualification required for the advertised posts. (ii) Attested Xerox copy of Caste Certificate from competent authority. The caste certificate should have been issued by the competent authority during the last one year time (iii) Attested Xerox copy of Residential Certificate from the competent authority. The Residential Certificate should have been by the competent authority during the last one year time. (iv) Attested Xerox copy of Character Certificate from the Head of the Institution last studied. (v) A recent passport size photograph duly attested by a Gazetted Officer to be affixed in the application form (vi) A good quality self addressed stamped envelope (Res. 5/-) of size 11 cm X 25 cm. (vii) A Bank Draft of Rs. 200/- (Rupees two hundred) only (non-refundable) payable at S.B.I., Cuttack Main Branch in favour of the District Welfare Officer, Cuttack by the candidates other than ST candidates applying for the post.
