As per the modalities devised for selection of candidates to work as staff of convergence child Labour Project, Cuttack following the guidelines & requirement prescribed by the ILO, DWT for South Asia & Country Office of India the four tier assessment was made for 50 (Fifty) marks comprising (1) Academic & Career Achievement – 20 marks, (2) Experiences – 10 marks (3) Viva Voce test -10 marks & (4) Computer knowledge test – 10 marks, for the posts of Sl No. 1 to 4. For the Sl No. 5 category of post i.e Field – Cum – Community worker no test was required on computer knowledge hence the assessment was 3 tier for 40 marks.

Following the modalities of above prescribed assessment the final merit list of candidates was draw up in each category of post.
