



Specifications & Other Terms & Conditions

1. The high mast poles to be strong enough to sustain wind velocity of 200km/hour.
2. The offer must specify the thickness & type of pole to be erected, total load/energy to be consumed per hour, details of foundation concrete, details of panel box & cables to be used, details of mechanical arrangements to be made for maintenance work.
3. The rate quoted must include the cabling charges from the nearest electric point, provision of meter & earthing, the transportation charges to the site located inside the premises of SCB Medical College & Hospital, Cuttack and inclusive of all taxes & other charges if any.
4. A security deposit worth Rs. 5000/- (Rupees five thousand only) in shape of Bank draft made in favour of Collector cum Chairman, District Red Cross Branch, Cuttack, refundable to unsuccessful bidders after finalization of the bid and to the successful bidder after completion of the project must be enclosed with the quotation.
5. Rates per unit of the item must be quoted clearly and total value be indicated in words & figures without any scope for revision.
6. All items to be supplied will have one year comprehensive warranty. Conditions for replacement/repairs of materials should be clearly mentioned.
7. Items to be supplied are subject to inspection and if found of inferior quality the same shall be replaced by the agency without any extra cost.
8. The authorized dealership certificate of the firm along with copies of valid TIN number, up to date VAT clearance certificate, PAN number/ card, Broachers of
