





2. The tender paper will be opened on 26/05/2011 at 11.00 AM in the Office Chamber of Sub-Collector, Sadar Cuttack in the presence of Tender Committee members / Tenderers.
3. The tenderers are required to remain present with their samples or send their representative with samples to attend the tender committee meeting.
4. The rates quoted by the tenderers should be inclusive of all taxes and the delivery of goods will be made at ICDS Project, Cuttack City at cost of the Supplier.
5. The tenderer should have valid Sale Tax / VAT Clearance and VAT registration Certificate with PAN.
6. The tenderers are required to deposit Rs.10,000/- only in shape of NSC / TD duly pledged in favour of Cuttack City as earnest money at the time of submission of Tender paper.
