



**QUOTATION CALL NOTICE**

Sealed quotations are invited from intending Vehicle Owner / Traveling Agencies for supply of Car for use by the Child Development Project Officer, Cuttack City on monthly hiring basis for Official use until further orders. The vehicle shall be hired on following terms and conditions.

1. The intending vehicle supplier should quote the rate of hiring charges on monthly basis excluding fuel. The Vehicle should be within two years of purchase.
2. The salary of the Driver, repairing, maintenance and other taxes etc. of the vehicle will be borne by the Vehicle Owner. The P.O.L. for the Kilometers covered on days of service will be provided as per norm accepted in the tender.
3. The hiring charges will be paid in every succeeding month.
4. The minimum quoted rate and rate of consumption of fuel and model of the vehicle will be considered for acceptance of quotation subject to approval of the Authority.
5. The Vehicle Owner of the accepted quotation shall have to sign an agreement with the undersigned before placing the vehicle in to Govt. Service.
6. In case of violation of agreement by the Vehicle Owner or any difficulties experienced by the undersigned in getting service / use of the Vehicle, the same shall be disengaged from Service without assigning any reason thereof .
7. The interested parties are requested to apply with details of vehicle such as model of the Vehicle, Regn. No., Permit No., Period and Tax Paid, Insurance Coverage (The attested Xerox copies of all documents need to be enclosed with the quotation)
8. The last date of receipt of sealed quotation in the Office of the undersigned is 16/4/2010 (Upto 1.30 P.M.) and the same shall be opened on the same day at 3.00 P.M. in the Office room of the undersigned in the presence of the quotationer(s) or their authorized persons.
9. The undersigned reserves the right to cancel the notice and any or all quotations without assigning any reason thereof.
