

QUOTATION CALL NOTICE.

Sealed quotations are invited from the reputed firms to supply and install 8 numbers Iron display board (hoardings) in 8 Block headquarters of Cuttack Sadar Sub-Division. The size of the display board is to be 8' X 6' Important provisions of PCR Act for SCs and STs (POA) are to be written in the board with letter size for the head line 5" X 4" and sub-head line 4" X 3" and subject line 2 1/2" X 2". The written matters to be supported from the back side by M.S. Flats thickness i.e. (F 32 X 4). Angle to be used for legs which will stand on the ground i.e. 50 X 50 X 6 MM. Around the board, angle size 40 X 40 X 6MM. The entire process of the work will be completed within a month from the date of receipt of the work orders. 
