## TENDER CALL NOTICE

The Project Director D.R.D A. Cuttack invites sealed tender from reputed manufacturers/ authorized dealers for purchases of Mobile C-Arm Unit for Digital imaging (C – Arm X-Ray Imaging Unit) in SCB Medical College Hospital Cuttack. The last date for submission of tender is on 10.11.2005 up to 2 P.M., and will be open on the same day at 4 P.M. in the Office of the Superintendent, SCB Medical College Hospital, Cuttack in presence of the meanderers or their authorized representatives, who should be present on the scheduled date and time for opening of tenders. If any bidders fail to be present, there is no bar for opening of tender. The tenderer should deposit Rs. 50,000/- (Rupees fifty thousand only) as EMD in shape of Bank Draft duly pledged infavour of the Superintendent, SCB Medical College Hospital, Cuttack. The tender Paper containing detail terms and conditions along with technical specifications of the equipments will be available at Store Section of SCB Medical College Hospital, Cuttack in any working day i.e. 10 to 5 pm from 18.10.05 to 31.10.05 on payment of Rs. 200/- (Rupees two hundred only) in the Accounts Section of S.C.B Medical College. The tenderer should furnish attested Xerox copy of STCC (VAT)/ITCC/authorization certificate from the manufacturers (in case of Authorized dealer) along with copy of money receipt and paper clipping of tender advertisement in Original or Xerox in the quotation. The rate should be quoted in Indian currency and the tax value should be clearly mentioned separately. The make and product, specification, period of validity of quotation and delivery period should be mentioned in the quotation. All documents and specification should be closed in separate envelope 'A' and the price quoted for the item should be closed in an envelop 'B'. Both A and B envelop should be sealed in another envelop superscribed as provision of Mobile C-Arm Unit for Digital imaging ( C-Arm X-Ray Imaging Unit) in S.C.B. Medical College Hospital Cuttack. And Index be attached in the first page of technical bid indicating the list of all documents enclosed duly signed by the tenderer..


