





The last date of receipt of Quotation is 05.03.2010 and will be opened on the same day by 4PM The intending suppliers would submit their quotations alongwith samples of Iron Sardi, Jungle Cutting knife, Jhampi made two bamboo Cane palmleaf, danka , Glass tumbler etc. The person concerned or his authorised agent may remain present during opening of Quotation. The suppliers should submit the Income Tax, Sales Tax assignment Certificate for the year 2009-2010 . The Sales Tax payable on purchase of Goods must be shown separately in the tender Quotations as well as in the bill. This position of Sales Tax shall not be taken into account while preparing comparative charts as per Finance Deptt. Circular No. 147/93/48625/F, dated 24.11.1998 and CTA 130/921897/F, dated 13.01.1993 . The Sales Tax portion of the bill shall be deducted from the dues of the suppliers as per provisions or sanction 13 AAA to Orissa Sales Tax Act Rules made there under in the Supplier being a registered dealer under the Sales Tax Act. States in the Quotation and the bill/invoice that the goods to be supplied to the Deptt. are not exigible to Sales Tax on the ground that either it is exempted or it supplier is not registered dealer than the Sales Tax as applied must be deducted from the billed amount even if Sales Tax is not separately shown in the bill. The details of items can be obtained from the Medical Officer of Health, N.F.C.P. Unit, Cuttack at C.D.M.O. Campus during officer hour on working day only Medical Officer of Health, National Fileria Control Programme Unit, Cuttack.
